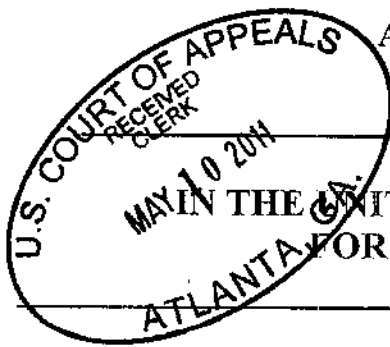

William M. Windsor (“Windsor”) hereby submits this EMERGENCY MOTION FOR STAY to this Court for consideration. The issue for this Court is very simple: Judge Duffey does not have the legal authority or jurisdiction to continue with matters in the District Court that are the subjects of appeal with this Court. The case law is overwhelming. Since Judge Duffey refuses to order a stay and violates the terms of his very orders in other such cases, this Court must order a stay to protect Windsor from the abuses of Mr. Duffey. Windsor shows the Court as follows:

1. Windsor has attempted to file Motions for Stays in the District Court, but Judge William S. Duffey, Jr. (“Judge Duffey”) has ignored them or denied them. (See Exhibit A for one example.) Judge Duffey denies due process and interferes with Windsor’s rights by requiring that Windsor submit Requests for Specific Approval to file anything, and then he ignores them. Judge Duffey also illegally interferes with the District Court Clerks staff to deny Windsor the right to file documents with the Clerk.

2. This is an EMERGENCY MOTION because Judge Duffey is ordering Windsor to produce the discovery that is the primary subject of Windsor’s appeal filed earlier this date and appear in court on Friday, May 13, 2011. Judge Duffey has accused Windsor of committing the crime of forgery, and he has ordered Windsor to appear in court on Friday, May 13, 2011 but has not afforded Windsor


NOTICE OF APPEAL
