ORDER

Pending for review at this time are various Motions for Leave to File submitted by Defendant William M. Windsor on November 29 and November 30, 2010, as follows:

1. Motion for Leave to File Verified Complaint Against Orinda D. Evans for Violation of Constitutional Rights [Doc. 952], which is DENIED.
2. Motion for Leave to File Motion to Recuse Orinda D. Evans Due to Pervasive Bias [Doc. 953], which is DENIED.
3. Motion for Leave to File Rule 60(d) Action and/or an Independent Action in Equity to Set Aside Order Dated November 22, 2010 [Doc. 954], which is DENIED.
4. Motion for Leave to File Verified Petitions [Doc. 955], which is DENIED.
5. Motion for Leave to File Motion for Reconsideration [Doc. 956], which is DENIED.
6. Motion for Leave to File Motion for Conference [Doc. 958], which is DENIED.

7. Motion for Leave to File Motion for Clarification [Doc. 959], which is DENIED.
8. Motion for Leave to File Motion for Hearing on Motion for Reconsideration [Doc. 960], which is DENIED.
9. Motion for Leave to File Motion for Subpoenas [Doc. 961], which is DENIED.
10. Motion for Leave to File Affidavits [Doc. 962], which is DENIED.
11. Motion for Leave to File Motion Regarding Compliance with Contempt Order [Doc. 963], which is GRANTED.
12. Motion for Leave to File Motion for Hearing [Doc. 964], which is DENIED.

Regarding Mr. Windsor's Motion for Leave to File Motion Regarding Compliance with Contempt Order [Doc. 963], the Court notes that on April 26, 2010, it found Mr. Windsor in contempt of Court, as follows:

. . . Defendant William M. Windsor is in contempt of court for filing his "Verified Complaint" in the United States District Court for the District of Columbia against Maid of the Mist Corporation and Maid of the Mist Steamboat Company, Ltd., and its attorneys, Carl H. Anderson, Jr. and Hawkins & Parnell LLP.

Windsor may purge himself of contempt by taking the following actions:

- 1) move to dismiss with prejudice all claims against Maid of the Mist Corporation, Maid of the Mist Steamboat Company, Ltd. and its attorneys, Carl H. Anderson, Jr. and Hawkins & Parnell LLP, in the action currently pending in the District of Columbia, and furnish written proof of same to this Court by May 5, 2010;
- 2) pay a fine for contemptuous conduct in the amount of \$5,000.00 into the registry of this Court by delivering a cashier's or certified check to the Clerk of this Court no later than May 5, 2010;
- 3) reimburse the Maid entities for the attorneys' fees incurred in the filing and prosecution of


the contempt motions and for work done on the District of Columbia litigation, in the total amount of \$19,010.00, paid by certified or cashier's check and delivered to Carl H. Anderson, Jr. at Hawkins & Parnell LLP no later than May 5, 2010.

[Doc. 794 at 34-35 (footnotes omitted).]

The Court's understanding is that at this time Mr. Windsor wishes to show that he has purged himself of contempt. Mr. Windsor is GRANTED permission to file such a motion, not exceeding 25 pages in text. The only papers which may be filed as attachments are any notices or letters Mr. Windsor sent officials of the U.S. District Court for the District of Columbia or the U.S. Court of Appeals for the District of Columbia regarding dismissal of Mr. Windsor's case against Maid of the Mist. Maid of the Mist may file a response if it wishes to do so.

Because the undersigned has entered an Order today granting Mr. Windsor's request for a stay in this case, Mr. Windsor's motion to show compliance does not need to be filed immediately. It must be filed within fifteen (15) days after the stay is lifted, however.
