Ms. Seagraves:

I sent an email to your office on August 3, 2009. Here is that email:

ACLU:

I have filed a pro se lawsuit against the United States of America and Judge Orinda D. Evans. I am finding that the federal courts here seem to be ripe with misconduct and much worse.

Is there someone that I could spend a few minutes with to tell about this?

I have not heard from anyone, and I am anxious to speak with someone.

I have at least one extremely important pro se/prisoner rights issue that needs an 11th Circuit and Supreme Court precedent. It involves denying the most basic right of self-representation when attempting to recuse a judge under 28 U.S.C. 144. The law says a certificate must be filed from "counsel of record." But a pro se party has no "counsel of record," yet my attempts to file my own certificate is met with judges saying I have to have an attorney to file one for me. No attorney wants to sue several judges, so I can't get an attorney despite my best efforts.

I have discovered that the judges of the Northern District of Georgia and the Eleventh Circuit ignore the facts and the law on a routine basis to accomplish whatever they personally want. I am absolutely flabbergasted. I naively thought judges were honest.

My case has several other interesting civil liberties issues regarding suing judges. As you know, there is a lot of case law that says judges have immunity from civil actions, but not criminal. The U.S. Attorney and FBI refuse to consider my complaints against Judge Evans, so their attitudes essentially give judges immunity from criminal prosecution.

Well, I am suing Judge Evans for civil RICO based upon criminal predicate acts. I cannot find any precedents, but I suspect Judge Duffey will dismiss it because he is hopelessly biased against anyone who would have the audacity to sue a judge.

My other claim against Judge Evans is fraud upon the courts. This FRCP Rule 60(d) independent action can be brought only against officers of the court. That means attorneys and judge(s). I suspect Judge Duffey will improperly dismiss it as well.

I have a lot of proof and research about the denial of pro se rights.

I am not looking for an attorney, but I would hope that the ACLU might consider an amicus curae brief when I take something to the Supreme Court. I am also open for any and all suggestions or ideas. I am not an attorney – just spending full-time researching the law as I fight injustice.

Please advise. Thank you.
