Dear Mr. Howard:

I need to file criminal charges against Cynthia Nwokocha, Deputy Sheriff Roye, and Deputy Sheriff English as well as additional charges against Naomi Fudge. Please contact me for the details.

Today, Cynthia Nwokocha committed several crimes in the elevator lobby of the third floor. She gave me a “Criminal Trespass Warning” and had me removed from the building. She has no right and no legal basis to do such a thing, and I ask that this be withdrawn by you in writing immediately.

I have a half dozen witnesses as to what took place as well as a tape recording. Ms. Nwokocha objected to me advising my friend that Ms. Nwokocha gave absolutely false and deceptive information as my friend tried to file a complaint with the Grand Jury. Her actions constitute violation of the First Amendment as well as violation of criminal statutes for obstruction of justice and jury tampering.

Ms. Nwokocha had no explanation for this ban from returning to the elevator lobby because the only justification is to continue the cover-up of the illegal acts by you and your staff and the pattern of criminal racketeering and jury tampering that has taken place for some time.

My specific purpose in coming to the elevator lobby every Tuesday and Friday is to present criminal charges to the Grand Jury against you, Mrs. Keel, Mr. Settles, Mr. Broadbent, Ms. Nwokocha, Ms. Fudge, Deputy Sheriff Betts, Deputy Sheriff Roye, and Deputy Sheriff English. It seems I need to add another 100 names to the list as I had letters hand-delivered to over 100 of your staff advising them that unless they get me before the Grand Jury, they will have committed crimes as well. No one responded, so I consider each of them guilty as well. I attach that list.

I have already submitted a Criminal Warrant Application with charges against Ms. Nwokocha.

I have never and will never damage any property of another without consent of that other person. (O.C.G.A. § 16-7-21 (a).)

I have never and will never knowingly and maliciously interfere with the possession or use of the property of another person without consent of that person. (O.C.G.A. § 16-7-21 (a).)

Unlike you and your employees, I have never and will never enter the courthouse for an unlawful purpose. (O.C.G.A. § 16-7-21 (b) (2).)

I have reviewed hundreds of cases this evening on O.C.G.A. § 16-7-21, and there are no cases that allow a citizen to be found guilty of Criminal Trespassing for entering a government building in a public lobby for the purpose of reporting crimes.

You and your staff are absolutely unbelievable – a criminal racketeering enterprise. Each of you needs to be locked up, and they should throw away the key.

Please withdraw this criminal action of Nwokocha in writing. Immediately.
