Ms. Barber and Mr. Harper:

As Ms. Barber knows, I was turned away from the Criminal Warrants Desk on Friday after I presented my six applications and \$60. Ms. Barber has these applications.

I must get these processed.

I am the victim of significant criminal activity by employees of the District Attorney's Office and the Fulton County Sheriff's Department. They have committed obstruction of justice and jury tampering in an all-out effort to block me from presenting my evidence to the Grand Jury. I have been repeatedly threatened by these Sheriff's Deputies. At least two of the people involved committed unbelievable tampering with the grand jury. The DA and Sheriff won't respond to my complaints because they don't want to go after their own, and I believe Mr. Howard has probably orchestrated the jury tampering. This means my only hope is to present my charges to the Magistrate Judge.

I am also the victim of theft by taking by a local attorney. I cannot wait to see if the Bar Association will act because this man has all of my financial and medical records, and I am unable to file by 2010 Income Tax Return (on extension as I had no records with which to file before) and do many other things that require those records. This man, Carl Hugo Anderson, has already damaged me severely by stealing these records. He filed a motion to have me found in contempt of court and then stole the records that I needed to prove I was not in contempt. I will likely be found in contempt and sent to jail for the first time in my 63 years as a result. I've never even had a traffic or parking ticket in Georgia!

I have also prepared a Warrant Application for a non-attorney, non-Sheriff's Deputy, Steve Broadbent. He is just a citizen who has committed crimes. I need him served at the DA's Office on Tuesday morning as that will be his last day there as Foreman on the Grand jury, and I have no other address. This man was a candidate for Chairman of the Fulton County Board of Commissioners, and he plans to be again. He is a liar, and he has committed criminal acts to block me from presenting to the Grand Jury AT THEIR REQUEST!

Should you attempt to deny me this right that I observed everyone else in town getting, please quote the statute that gives you this right.

My experience with every government official in Fulton County (except some with the Fulton County Clerk's Office) is that they are less than honest and could care less about damaging someone (me) out to stop some of the government corruption that we have. Please do not be part of that group.
