Dennis C. O'Brien provided Defendant some revocation materials on August 30, 2011; see and herein incorporate attached Exhibit B. The original April 2011 hearing before Judge King specifically stated Michael Hamilton was NOT an agent of PT Holdings. United States Probation Officer Lisa Moore stated under oath that at least one witness received threats so severe that the witness started sleeping with a gun under his pillow out of fear. The attached, and herein incorporated, Exhibit C further evidences Jerome Froelich, Robert Willison, Michael Garone, and/or those associated with them have been tampering with witnesses and evidence related to this case. During sworn testimony on August 30, 2011, Jerome Froelich stated he took out a "trial subpoena" in this case to receive the information provided with the letter shown in Exhibit D, which is attached and herein incorporated. I have contacted Fifth Third Bank and have evidence Jerome Froelich has lied under oath.

Stating the above are true statements, I hereby state the above this 1st day of September 2011.



I, Michael Hamilton, make this affidavit upon personal knowledge. I sign and swear to this Affidavit freely and voluntarily. I state and affirm the following:


1. My company was hired to work in and around Columbus, OH from June 2010 into August 2010.
2. During these three months, I worked with and oversaw the work of several other individuals that also were working as agents of companies separate from Mike Hamilton Construction. These people included day laborers and others that assisted with (among other things): (a) the repair of hundreds of rental property work orders, (b) the help necessary to handle the very heavy repair call volume we experienced from tenants, and (c) the assistance needed to handle the overwhelming paperwork associated with all the repair order tickets.
3. The hours I submitted do not include the hours and expenses of the other agents of PT Holdings Group I, Inc ("PT Holdings").
4. I am personally aware Robbie Willison knew of the details of the liens placed on the Columbus properties, knew of my work, and knew of the work of other agents of PT Holdings before he signed and provided his November 15, 2010 AFFIDAVIT (see attached Exhibit 'A') and GENERAL RELEASE (see attached Exhibit 'B') because Robbie Willison acknowledged these items in his sworn statements.
5. Scott Hintz never represented he owned any part of PT Holdings nor do I have any reason to believe that he got any personal benefit from this company; Robbie Willison's sworn statement acknowledges Net Five was 'completely aware these same transactions occurred between The Entities and PT Holdings Group I, Inc and Mike Hamilton Construction while these entities were fully owned by close friends of one or more employee(s) of The Entities.' (see attached Exhibit 'A').
6. I received several unfulfilled promises for several months to receive payments by senior members of Net Five management between August 2010 and December 2010.
7. I have no personal knowledge of Scott Hintz doing anything illegal with any dealings with me or Net Five. He has always dealt with me fairly, even when Net Five would not.
8. In December 2010, and early January 2011, I received threats from one senior member of the Net Five management team and at least one attorney allegedly working with them. These threats were used to coerce my actions because they knew I was financially vulnerable and unable to protect myself from them.
9. These threats included, but are not necessarily limited to, statements that if I did not sign off on the Columbus Ohio liens and if I talked to or associated with Scott Hintz, they would ensure I never would get the money owed to me, they would ensure I went to jail for thirty years, they would ensure my wife lost her job as a teacher, and I would lose everything I own including my home.
10. In fact, I was so scared after receiving the threats in numbers 8-9, above, that I began sleeping with a gun by my pillow.
