**REQUEST FOR SPECIFIC APPROVAL TO FILE MOTION FOR
CLARIFICATION OR MOTION FOR CONFERENCE**

Comes Now, William M. Windsor (“Windsor”) and requests approval to file a Motion for Clarification, or in the alternative, a Motion for Conference. Windsor shows the Court as follows:

1. The Order dated April 21, 2011 [Doc. 152] grants Plaintiffs’ motion to compel (“ORDER 152”). P.5¶3 falsely and maliciously claims “heavily redacted” when 68 pages were provided with 1/3 of one page redacted, consisting solely of social security numbers and account numbers.
2. Windsor requests clarification from the Court as to whether personal information such as social security numbers and personal information of others must be provided without redaction.

3. ORDER 152 directs Windsor to file certain information under seal with the Court. Windsor seeks clarification as to whether this information is not therefore to be provided to the Plaintiffs.

4. The Standing Order of this Court provides that a conference should be requested in a situation such as this. A brief teleconference will be sufficient. If the Court agrees to this, Windsor respectfully requests that the Court have Ms. Jessica Birnbaum send Windsor notice by email to williamwindsor@bellsouth.net so he will have timely notice.
