On October 7, 2011, this matter came before the Court for a hearing on William M. Windsor's request for temporary injunctive relief. The Court heard argument from the parties and testimony from Plaintiff and other witnesses.

FINAL ORDER

Judge Thrash of the Northern District of Georgia has issued a permanent injunction against Mr. Windsor, prohibiting him, or anyone acting in concert with him or at his behest, from filing any complaint or initiating any proceeding in federal or state court without prior approval of a federal judge. Mr. Windsor did obtain an order from Judge Thrash allowing him to file this complaint. Judge Thrash's order allowed Mr. Windsor to file the complaint only because the claims in the complaint did not fall within the specific terms of the injunction. Judge Thrash did not address the merits of Mr. Windsor's claims.

After considering the entire record, as well as the argument and testimony at the hearing, the Court has determined that this matter is frivolous and without merit. Therefore, this matter is <u>sua sponte</u> DISMISSED. <u>See Smith v. Adamson</u>, 226 Ga. App. 698, 699 (1997).

Furthermore, the Court takes judicial notice of the previous lawsuits that Mr. Windsor has filed in this Court and federal court, and also takes judicial notice of the District Court and Eleventh Circuit's determinations that Mr. Windsor's litigious behavior is, and has been, an abuse of the judicial system.

Based on Mr. Windsor's conduct in the federal courts and this Court, including the voluminous, meritless filings in this case, the Court finds that it is necessary to issue a permanent injunction and hereby PERMANENTLY ENJOINS Mr. Windsor, and any parties acting in

concert with him or at his behest, from filing any complaint or initiating any proceeding, including any new lawsuit or administrative proceeding, in any Fulton County state court (Superior, State, Probate, etc.) or agency in Fulton County without first obtaining leave from the presiding judge in the Superior Court of Fulton County. If the lawsuit or administrative proceeding names a Fulton County judge, court personnel, or employee, Mr. Windsor shall tender \$50,000 into the registry of the Fulton County Superior Court, which money will be used to pay any sanctions imposed against Mr. Windsor for filing a frivolous complaint or initiating a frivolous proceeding. When seeking approval to file a complaint or initiate a proceeding in Fulton County, Mr. Windsor shall attach to his proposed filing this Order and Judge Thrasher's permanent injunction Order entered in Windsor v. Hatten, 1:11-CV-1923-TWT (N.D.Ga.) on July 15, 2011.

The Court also PERMANENTLY ENJOINS Mr. Windsor from entering the floor of the courthouse where the Grand Jury meets without prior permission from the presiding judge of the Fulton County Superior Court.

This case is CLOSED.
