DECLARATION OF CARL H. ANDERSON, JR.

CARL H. ANDERSON, JR. ("Declarant") states and declares that the following statements are true and correct and based upon his own personal knowledge:

1.

Declarant is an attorney licensed to practice law in the State of Georgia. Declarant is the counsel representing Plaintiffs in the above-styled case.

2.

Declarant is employed as an attorney by the law firm of Hawkins & Parnell, LLP ("HP"). HP serves as counsel of record for Plaintiffs in the above-styled action. A copy of the law firm's entry in Martindale-Hubbell is attached hereto and incorporated herein as Exhibit "A" to outline the experience level of the attorneys who have worked on this file.

3.

Declarant is a graduate of the Walter F. George School of Law, Mercer University; was admitted to practice law in Georgia in 1987; served as a law clerk to the Hon. Frank C. Mills III, Chief Judge, Blue Ridge Judicial Circuit, State of Georgia, from 1987 through 1989; practiced law with the law firm of Stepp, Bowers & Smith from 1989 to 1993; practiced law with the law firm of Wayne Reece, P.C., doing business as Reece & Associates from 1993 to 1998; and joined his present employer as an associate attorney in 1998. On July 1, 2001, Declarant became a partner at HP. Declarant has more than twenty (20) years experience practicing law.

4.

Declarant normally practices in the business litigation group. In that practice group, Declarant's current billing rates for non-insurance litigation range

from \$225.00 to more than \$290.00 per hour. Declarant has billed clients at those rates, has invoiced them, and has received payment from them at those rates.

5.

The law firm assigned this file to Declarant because he has previous experience handling business tort and injunctive relief claims. Declarant has not increased the billing rate during his representation of the Plaintiffs. Declarant has prepared a table using information available in the Fulton County Daily Report and through Martindale-Hubbell to help him establish that the HP timekeepers' rates are reasonable. A copy of the table is attached hereto and incorporated herein as Exhibit "B".

6.

It is Declarant's experience and opinion that the quantity of time worked by Plaintiffs' counsel for which compensation is sought is reasonable and consistent with the requirements of this case and the billing judgment exercised in comparable cases in the Atlanta market for comparable legal services. The staffing on these cases and the time charges resulting from these staffing decisions appear, in Declarant's judgment, to be reasonable, necessary, and consistent with the prevailing market conditions in 2009 for the delivery of comparable legal services in comparable cases. Based on Declarant's review of the table attached hereto as

Exhibit "B" and his knowledge of rates in the Atlanta area, HP timekeepers' rates are reasonable (if not low.)

7.

Declarant is the attorney at HP who is most familiar with this case having spent numerous hours working on this file.

8.

Declarant states that it is the policy and practice of attorneys and paralegals at HP to enter time into the law firm's time-keeping computer program contemporaneously with the performance of the service rendered or as soon thereafter as practicable. Each timekeeper enters time in the computer in six (6) minute increments or tenths (1/10th) of an hour. Each timekeeper must input the client number, the matter number, the time expended, a description of the service performed, and, in some cases, client-specific task codes. In this case, the client number is 4135 and the matter number is 190940. Under the engagement letter, the minimum time entry is two-tenths (2/10th) of an hour. Each timekeeper is responsible for releasing his time to the accounting department for the previous week no later than the following Monday afternoon at 5:00 p.m. Once each timekeeper has released his time, the accounting department can generate a pre-bill which sets forth the name of the timekeeper, the date the service was rendered, the

amount of time expended, a description of the service rendered, and, in some cases, client-specific task codes. HP's time and billing records are kept in the ordinary course of business. HP stores the bills which HP generates in the file. Declarant is the custodian of this file.

9.

Declarant has reviewed the file in which HP keeps the bills that it generates. Declarant derived the information in billing abstract from the billing files. Declarant will supplement his Declaration with Excel® billing abstracts under Rule 54(d)(2)(B) of the Federal Rules of Civil Procedure and LR 54.2A(2). The billed attorney's fees and expenses for HP total \$170,159.50 and \$2,899.53, respectively, as of November 30, 2009. This represents approximately 692.1 hours. The unbilled attorney's fees and expenses for HP total \$54,022.50 and \$1,044.95, respectively, as of December 31, 2009. This represents approximately 211.5 hours.

The following table sets forth the abbreviations which identify certain timekeepers.

Further, Declarant states that the billing rate for senior partners on this file is \$315.00 per hour, that the billing rate for partners on this file is \$275.00 per hour, that the billing rate for of counsel is \$260.00 per hour, that the billing rate for associates is \$225.00 per hour, and the billing rate for paralegals on this file is \$145.00 per hour. These rates have been in effect for all of 2009.

10.

Declarant states that he calculated the amount of attorney's fees due by multiplying the total number of hours that an individual worked on the file by that individual's billing rate. Then, Declarant added the products of each of the calculations together. The sum of that calculation equaled the amount of attorney's fees. Based on the calculations which Declarant performed, the amount of attorney's fees incurred by Plaintiffs through from April through December 31, 2009, for the handling of the litigation is \$224,182.00. This represents approximately 903.6 hours of time. Further, the amount of attorney's fees incurred does not include time for January, 2010, which cannot be accurately generated until the close of the month. The expenses (including items that may be taxed as

costs in a bill of costs) total \$3,944.48. Declarant will supplement his Declaration with Excel® billing abstracts under Rule 54(d)(2)(B) of the Federal Rules of Civil Procedure and LR 54.2A(2).

Plaintiffs directly incurred other legal fees and disbursements in New York in the amount of \$16,446.89 and \$45.30, respectively. (See Affidavit of Marc W. Brown, ¶ 12).

11.





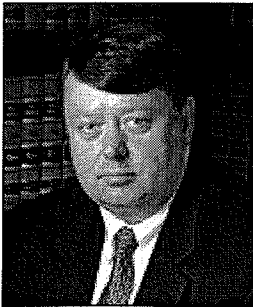
