COMES NOW Plaintiff William M. Windsor, and moves this Court to request consent to file a NOTICE OF LEAVE. Windsor shows the Court as follows:

- Windsor's wife, Barbara, is having major surgery on November 7,
 2011 that will leave her incapacitated for a month or more.
- 2. Barbara Windsor requires surgery for a prolapsed uterous, rectocele, and related issues. A rectocele results from a tear in the rectovaginal septum (which is normally a tough, fibrous, sheet-like divider between the rectum and

- vagina). Rectal tissue bulges through this tear and into the vagina as a hernia. A hysterectomy will be performed, and her uterous and ovaries will be removed. An assortment of other procedures will be done to repair problems in the vagina and rectum, and she will have a hysterectomy. Dr. Dobson says Barbara will be out of commission for six weeks.
- 3. Barbara will be unable to do much of anything for a month, and Windsor is her sole caregiver. She will be in the hospital for a few days if all goes well.
- 4. Barbara began medication earlier this year for another problem that had to be resolved before the surgeon would operate. The doctors gave the goahead a few weeks ago, and the surgery was scheduled at the first available time.

WHEREFORE, Windsor requests that the Court do as follows:

- (1) grant this REQUEST;
- (2) allow this REQUEST to be filed as the Notice of Leave;
- (3) schedule nothing during these dates, and allow Windsor to respond to anything currently due for a response on or after November 3, 2011 within 14 days after he returns from leave; and
