### **WoW an Email.. Thank You..**

Michael Spreadbury came to Eureka awhile back, he was with a guy shooting a documentary, I was not there and did not meet him.

Internet Marketing, Blogs is What I do. As well as I am a Real Estate Broker Owner.

I had heard about the documentary and read some on the bitterroot rising site that Michael Spreadbury owns, I liked what I had read so I bought [MichaelSpreadbury.com](http://MichaelSpreadbury.com) ( I own the domain name of quite a few people) .. anyway I am helping a local gal, a lady cop her with her internet marketing in running for mayor so I thought helping him would bring balance and it "Seemed" they had similar platforms, similiar chore values and such..

So I built the blog and gave Michael Access after I called him and told him that is what I as doing, he was fine with it..

then he emailed me stuff to post, called when he did a video and asked me to post it I did, we talked on the phone about his Mayor run and Montana politics a couple times.. when I got my death threat I sent it to a few folks.. I posted stats on my blog, he called and asked more about it, we emailed back and forth.. I told him that local judge had denied me a protective order because he was not family and I did not have one hundred percent tracking on the Death Threat, though I had quite a bit of other proof..

Michael Called me and asked me to come to Hamilton to interview for the documentary on stuff

that was going on in Eureka, he also said that he had "connections" to judge haynes and that seeings how Sean Boushie lived in Stevensville he was sure I could get a protective order against Sean in Hamilton with the Distric Court..

When I got there, yes he helped me fill out the protective order, however, he said this prob. won't work but we will try, though i drove 5 hours I went with it and though he had said it would work as if he already talked to "people" .. well..

so we took the order to the courthouse.. it was denied, I wanted it in writing.. Mike and I asked that the judge give it in writing..

so we left..

we went together to the Denny Rehberg listening session I sat way opposite of him and filmed most of it..

after we left .. long story short on that.. he asked the camera guy for the documentary to come to the courthouse with us .. so he did, I was denied, it was filmed, the camera guy asked michael to stay outside he, he came in.. they denied my order .. the guy filmed it and my response, they asked the camera to leave.. i was gone.. don' t know what else mike said, the camera guy came out and left..

then one cop showed up, then 2 .. then 5 then a reporter..

In my opinion, Michael Spreadbury never really thought **he could "help me"** - he simply used **my REAL SITUATION** to further his cause, to incite the cops and to create more media, more video for his personal agenda, in which was **not about helping me**.

There were witnesses to all of these events. And this **"Alleged"** footage Michael Spreadbury brags about having on his site, **it is MINE, and it Will NOT be Shown**.

If I had footage of after the Hamilton Cops took me aside to ask me questions you would hear **Michael Spreadbury** yelling at the cops so loud that I could not talk to the Officer that was **actually trying to help me**.

The Officer that did talk to me about my Death Threat, MY ISSUE.. had a hard time hearing me or talking because Michael Spreadbury was yelling in the background at the other 4 cops on the scene, then after his yelling ended.. he sat on a bench next to us and started bitching at the cop that was helping me. And all this in the name of **"Helping Crystal Cox"** - that is simply NOT TRUE.

The Officer was giving me real help, he was about to give me names to further help me and Michael Spreadbury called me to the truck like a dog, and well I Had to Go.. I was riding with him.. so there ended my HELP that I had finally started to get after trying the whole day.

**then It Became all about Michael Spreadbury.**

My car was at his house, so we went back there, once there he was repeating what happened over and over, with F%\$# this, F&\*%\$ that... I tried to read what the Judge had said, Because this was about me Right, NOT.. I could not read it because Michael was yelling over and over about what happened, and yelling about firing them all, revoking the Ravalli Republic License.. he called the paper and chewed them out, then he called the Missoula Police FOR ME.. without my permission.. he would not calm down. Finally, and I dont' remember cussing, but he claims I did, I asked him to Calm Down, he turned on me bigtime, he told me not to talk to him that way, not to cuss in his home and to leave his home.. I gathered my things and asked that he please stay calm while I gather my things..

I went to my car, when I came back in for my papers, he Said Aren't you going to Apologize, well that Lit me up.. dont' remember exactly what I said, but the F word then came out front and center.. I said F.. that, I have NOTHING to apologize for .. I DID NOTHING..

So he turns on me, endangers me, almost gets me arrested, is in a mad tirade and then wants me to apologize.. And now professes shamelessly over and over that all he did was help Crystal Cox...

Since I left he has escalated a situation in which I had intended to walk away from, I left his site up with his words from him and from his other site as was, however he emailed and called folks in Eureka and told them lies about me, this went on for about a week and yesterday he said on an email to one of them that he "gets my death threat"..

I realize he called you on my behalf, however, I did not ask him to and was not planning on talking to the Missoula Police until I had my Supoena's done from my attorney so as to come to you with very good evidence, I have alot of stats, the death threat and a whole lot of reasons why I know it to have come from Sean Boushie but I had planned to wait. Mike called you in effort to quite down the law enforcement roar he stirred up in Hamilton, with 5 cops.. he put me in a serious situation with law enforcement in his "attempt" to help me.

And yesterday he left a message on a local guys phone, saying he hopes I get what I deserve.. after a week of emails to locals here in Eureka about me.. I did nothing to him, he turned on my badly, I left town.. Now I will be telling my side..

I had enough and defended myself by now posting my story of the Day in Hamilton on My Blog.. MichaelSpreadbury.com ..

He is not a Friend of Mine, he does not speak for me.. him calling you, well I am not sure what that was about.. I would appreciate help but at this point don't really expect it..

**Now about Sean Boushie**, .. he sent the death threat I know it.. i think i emailed all the reasons it could only be him..

Yes he works at U of M.. he site on my site 7 to 8 a day Everyday while paid by the U of M..

and now there is a Police report in eureka that ties him to it.. but we wait for the information as I talked to my attorney at 8 am..

so long email.. longer story..

I know that you most likely none of you are fans of my blogs. They are Simply the voice of the People, what I am hearing, what I am seeing and I truly do have the best interest of all at heart in my writings.

**I have received a Death threat** and this threat is connected to **a Government IP** address, I have included Stats and Links in this Email to give you a better understanding of what is going on and what is being Ignored, as I await to be **"Permenantly Put Down"**. If you have NOT seen this Death Threat, it is in Justice of the Peace Stormy Langston's City Court and Justice Court Files as well as Stats and Proof of What I am about to say.

It has saddened me, the horror of the crimes, what I hear from the victims and that is what started my quest to give victims a voice. Whether it be children stuck in Meth Homes, Rape Victims, Men or Woman, People Beaten or Robbed or even Real Estate Victims, my Quest is to simply give them a Voice.

**Here in Eureka Montana** that partly turned into the request, the Petition to recall Sheriff Anderson and from that point I have certainly been in the thick of it as stories come to me daily from many different sources, emails, chats, phone messages, snail mail, and people stopping me in the street.

I am not out to hurt innocent people and I really do feel that What I am saying is the Truth. Surely with writings, with me voicing my opinion and talking about what I am hearing, surely none of you want me Dead Right?

I have tracked someone from the IP as is attached to the Stats. Also To give those of you who don't know a bit more background look at This site,

The Government IP searched "**Sandptcpl**" this morning, this Hate Blog has some of the same sentences as my Death Threat. "**Sandptcpl**" of course being the listed Author of the Above Hate Blog.

I now know that **Justice Court and City Court** is On this Mt.gov IP address. I do not know if these computers are password protected when the Judge is NOT around. I do not believe **the Judge is involved** though she has denied me to Testify for Paul Stramer against the Man who threatened to kill me, though she knew of this site connecting us prior to Paul Stramer's hearing.

These MT Government Connected Computers have our private Cases, Private information on Court Related Crimes, Reports, Protective Orders, Emails, or anything that you may tell, give or show a local Justice of the Peace or a City Judge?

**Are their Computers Password Protected** or can any cop, office staff, dispatch, highway patrol or cleaning company access that Computer that is linked in with the Montana Supreme Court System?

Stormy Langston Justice of the Peace in Eureka Montana knows who this man is, knows what he has threatened me with and for some reason seems to be protecting him.

Allowing him to verbally, with no proof get a **Protective Order against Paul Stramer** based on his word, his story, and though he lives over 4 hours away from him, and I bring Proof the best I can and My word, My Proof is NOT taken seriously when I have been permanently threatened to be Put Down. Judge Langston would not allow me to testify with **proof of this man's HATRED for Paul Stramer**, Why?

Shocking, now I know local Law, judges, Commissioners **do not appreciate my blog**, but I do not promote hate, I simply speak out for victims hurt in all this and **I Do not Deserve to have the County Boycott my Rights to be be Protected**. Or to Ignore My Threat of Being Put down and other Vile attacks and the Proof of the Connection within a local Government Office. **I simply have to wait**, I have to now Open Carry though that was something I never saw myself doing, I don't know if it is a cop that is associated with this man or WHO in the local government (MT.gov) network is with him on permanently putting me down, so I wait..

I have Proof Of Hate Mail coming from a Government IP Address and I am being denied a Protective Order against another man whom I know has threatened to Permanently Put me Down.

**I want a Permanent Restraining Order** based on my Fear, my Word and my Proof and I cannot have that so I am involving the FBI and All State and National Agencies I can and I am going to present my case through an attorney.

**This Government IP Sits on my Site Every Single Day**, I have those Stats after Stats, Day after Day. This Government IP is the Jimmy Boston email I posted awhile back, and the local Justice of the Peace has that information, I have not yet discussed this on my Blog Network. I intend to get my story out there.

Last Week, Stormy Langston Local Justice of the Peace Would not Let Me Testify on behalf of Paul Stramer though my email was extremely threatening and included hatred for and to Paul Stramer. **I offered proof of who this email came from.** Stormy Langston gave me a Restraining Order to fill out but said I could put no name as I did not know for sure who it was from.

**Judge Stormy Langston** told me she knew it was most likely that person, but she would still not let me put his name on a restraining order based on my word and based on my fear. But she gave this same man a restraining order against Paul Stramer based on his word and **NO PROOF.**

I have not written about any of this, though I do have an attorney and do intend to press Criminal Charges if I can. I have not written about it because I felt that first day that Stormy Langston was sincere in her words that **“this is not ok”** but still I can have no restraining order.

Now this Man does not live here, and YET can get a restraining order on a Eureka Resident. **The Judge heard him say he is moving back here FULL time**, he is now only here on the weekends. I was pretty convinced as of last Friday that Neil Duram was Talking with the Guy at the University of Montana , and that together they had both sent me hate mail and put my life in danger. Today I am assured that Neil Duram is not that kind of guy, the kind that would threaten to permanently put me down. Today I am told that Neil Duram is a kind man and that he would no way ever do anything even closely related to this as the person who told me has known him for decades apparently.

At first I believed it may be Neil Duram because I know his family has been friends with the family of That Guy, for at least 16 years and most likely longer.

So I am left with Who ever has access to Stormy Langston, the Mayor or other local official computers networked in with the State of Montana . So really it could be anyone in the Cop Shop Downtown or the Justice of the Peace office that is Coherting with the Person who threatened to Kill me.

He knows that Stormy Langston will do nothing, though it sure seemed that she really was

Crystal,

I have reviewed all of the materials on the links you have provided. Although I sympathize with the unfortunate situation that appears to exist on the Internet between you and Mr. Boushie, none of his activity appears to violate a federal criminal law (the limit of the FBI's jurisdiction). You certainly may have civil remedies for libel or damage to your business based upon his Internet comments, but you'd have to ask a personal attorney about that.

The only possible exception, would be the death threat you allude to, but I haven't seen the content or context of that communication. A decision as to whether that threat would constitute a prosecutable federal crime would ultimately fall to the United States Attorney's Office, not the FBI (we merely investigate). However, from my 15 years experience, I know that such charges are rarely brought, especially in circumstances such as this.

Unfortunately, as uncomfortable as it is, I am not aware of any federal criminal statute which would prevent someone from searching your name and address on the Internet, or posting nasty opinions or statements about you on websites. In short, if you want some relief, your best course would be to seek the assistance of a civil lawyer.

Sorry I can't do more to help, but our federal jurisdiction really is very limited, and the First Amendment makes it (appropriately) very difficult to limit speech on the Internet.

Hope you are safe, and this situation can be resolved.

Dear Dean Janson,

Thank you for your response, and your time. The persons "investigating" these allegations are allowing Mr. Boushie to continue improper computer use at your Department. When I read a University policy which states no excessive personal use, it does not take an expert, when proof of activity is given (a fax was sent to Ms. Claudia Denker-UM Legal) where 22 hours was spent viewing a person's site within the past week, and further proof exists of two years of data confirming this behavior.

I have found viruses, and worms in my computer when I have opened several comments on my site (I never contacted him). Mr. Boushie is bullying, and publishing false information, congratulating a former UM law student who successfully violated a court order on Student practice. The April 13, 2011 entry on [www.seanmboushie.blogspot.com](http://www.seanmboushie.blogspot.com) is premature: the Supreme Court for Montana has remitted the case (they will rehear it) and I did not "looses AGAIN (Boushie, 2011)"; its now false published information.

It should concern you that several complaints have been lodged against this employee in your department. An unsolicited invitation to view his site came in the last few days, to my personal email (unknown to him) which I declined due to the aforementioned results of prior sabotage. Thank you for sharing your concerns. These are very similar to allegations made against Mr. Boushie in the past, which have been investigated thoroughly and shown to be groundless. In any case, such serious issues are not properly dealt with by me, as they have obvious legal implications which I am neither authorized nor trained to deal with. I suggest that you approach the appropriate authorities with your concerns.
