**MOTION FOR SECURITY ON APRIL 8, 2013**

William M. Windsor ("Windsor") hereby files this MOTION FOR SECURITY ON APRIL 8, 2013. Windsor shows the Court as follows:

1. On April 8, 2013, a hearing on a Protective Order is scheduled.
2. Windsor is being asked to come to Missouri without any protection.

Windsor is being expected to enter a courtroom with people who have stalked, harassed, and threatened him.

3. Sean Boushie ("Boushie"), a man who says he will be at the hearing as the petitioner's bodyguard has sent an email to Windsor using KillBill@yahoo.com as his email address. [Exhibit A is a true and correct copy of the KillBill email message.] Windsor knows it was sent by Sean Boushie as Windsor has tracked the IP address that he uses.

4. Upon information and belief, Sean Boushie has also posted a threatening message. [Exhibit B is a true and correct copy of the posting.] The posting says: "I dare you, to bring that fat ass to to the land of OZ. You will need a lot

more than target lessons to take me on. You will need an ENTIRE army. ... c'mon... bring it on. ... Bill, I will see you in Missouri.”

5. Boushie has conveyed messages that are threatening to Windsor by posting messages using icons such as a Glock gun, Charles Manson's photograph, and a big knife. [Exhibits C, D, and E are true and correct copies of icons that Sean Boushie has used when posting on Windsor's Facebook page.] Boushie has made many threats. He has said that he would “give you an in depth lesson in Montana castle doctrine,” which is a threat to shoot Windsor. [Exhibit F is a true and correct copy of an email from Sean Boushie.] He has also indicated a desire to run over Windsor with a Mack truck. [Exhibit G is a true and correct copy of a posting by Boushie on Windsor's Facebook page.]

6. Claudine Dombrowski (“Dombrowski”) and the American Mothers Political Party are equally scary. In postings about Windsor, they promoted for all of their members to watch the movie “Kill Bill.” According to court records [Docket in Case # 96D 00217 in the Third Judicial District in Shawnee Mission Kansas], Dombrowski is volatile, has unpredictable behavior, and violates court orders. Dombrowski has publicized that she will be at the hearing on April 8.

7. In May 2011, Windsor was a guest on a radio talk show on the Republic Broadcasting Network. Following the radio show, Windsor was informed by the talk show hosts that they had been contacted by a federal prisoner through

his wife. The wife allegedly told the talk show hosts that her husband was approached by government officials from the FBI and Department of Homeland Security offering the man a deal. That deal was for him to infiltrate efforts of people, including specifically by name - William M. Windsor. This seems really outlandish, and Windsor does not know if it is true, but it did cause him to file a report with the police, and he was contacted by an agent with the FBI.

8. And Windsor believes Allie Overstreet (“Overstreet”) is capable of anything. Windsor believes Overstreet is mentally unstable. Overstreet fabricated an outrageous claim to get an ex parte order of protection against Windsor. She has lied about Windsor repeatedly. Upon information and belief, Overstreet has lied in Lafayette County courts making outrageous claims of sexual abuse by the father of one of her children. A person who would do crazy things such as this is certainly capable of attempting to harm Windsor or recruiting someone to harm Windsor.


9. Windsor is threatened regularly because he is exposing dishonesty and corruption in government and courts nationwide. There are many people who hate Windsor and would undoubtedly like to see him dead. Windsor believes that many of the haters are people who are mentally unstable and who could do just about anything. These haters now know when and where they can find Windsor when he is without protection – Lafayette County courtroom on April 8, 2013.

10. Windsor asks for security when he is in the courthouse. Windsor asks the Court to assign an armed law enforcement officer to Windsor at all times while at the courthouse.

11. For the reasons stated above, Windsor respectfully requests that this Court enter an order as follows:

- a. that Windsor's MOTION FOR SECURITY is granted;
- b. that an armed law enforcement officer will be assigned to protect Windsor at all times while at the courthouse; and
- c. for such other and further relief as the Court deems appropriate.
