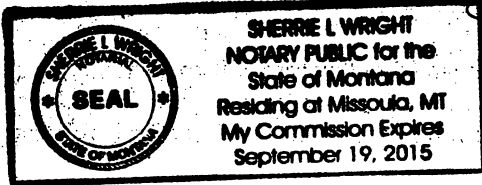


I, Sean M Boushie a resident of Ravalli County Montana, would request a temporary order of protection against William Windsor, aka "John Jones" a legal resident of Marietta Georgia, or Box Elder South Dakota, also believed to be currently homeless. Residing at the Marriot courtyard hotel room 402.

While I thank the court for its thorough investigation of the first application for an order of protection dated 8/14/2013. Several additional actions since 8/13 by William Windsor have occurred since that date which have driven me to once again ask for an order of protection.

1. On 8/16/2013 William Windsor made an appearance not only at the University of Montana, but he appeared at my workplace located in the Health Science Building wearing a bullet proof vest. He proceeded to question the Division receptionists Robin Hamilton, and Sherri Wright, and demanded to speak with my supervisor, Dean Charles Janson. Mr. Windsor admits to filming the conversation with Dean Janson without his knowledge or consent. (Please see attached notarized statements.) Everyone in the office was quite uncomfortable.
2. William Windsor proceeded to make his way to the fourth floor, and my office, HS 415. He proceeded to take photos, and was observed opening the doors to peer in and take photos. My coworker had her two small children with her and was terrified by his presence. He later posted the photos with a caption "I was wearing my bullet proof vest, and I had all of my other protective gear." Campus Security apparently eventually asked him to leave.
3. On 8/20 William Windsor was observed parked next to my red ford pickup, apparently taking photos of the vehicle. He later posted these photos. (See attached screenshot)

4. On 8/20 he posted a photo with a comment, "Tomorrow I may go see if Wynette Boushie will agree to an interview while Sean baby is at work." It does not matter if this was an actual statement, it was meant to harass and terrify both I and my wife.
5. On 8/21, he made yet another appearance on Campus, and I was notified by campus security.
6. William Windsor continues to accuse me of Lewd and Lascivious acts. He repeatedly posts photos of Fantast for Adults porn bookstore, and accuse me of going there to use glory holes.
7. He has and does use his face book account to encourage others to harass me. Attached is a disk containing one such voice message I was able to record, there have been several others. Also attached is a screen shot of a comment made by David Harbin, "Good friends are always on standby with shovels, plastic bags, and bleach..."

The actions of William Windsor have escalated, he has made several more personal appearances, and we do not feel safe at home or at work. I firmly believe the mental capacity of this individual is compromised in some way, and I beg the court for relief.

I have been harassed, intimidated and stalked online by Mr. Windsor for approximately two years. The harassment and intimidation by Mr. Windsor is generally directed and received at my place of employment, The University of Montana. He claims to be making a documentary about me and accuses me of being a state paid cyber stalker.

I have never spoken to Mr. Windsor. I have never emailed Mr. Windsor, contrary to his claims.

My only communication with Mr. Windsor was a cease and desist letter sent to his now ex-wife regarding his harassment on her website, lawlessamerica.com. Mr. Windsor ran the website; his wife was the legally registered owner.

Mr. Windsor also harasses and intimidates me on his websites, www.seanboushie.com, and www.lawlessamerica.org, as well as several facebook accounts, billwindsor1, lawlessamerica, and lawlessamerica-montana.

Until recently Mr. Windsor's harassment was entirely cyber. However as of 8/5/2013, Mr. Windsor has traveled to Missoula, Montana to stalk, threaten, harass, and intimidate me in person. He has repeatedly been spotted near my home, and my place of employment, where he has no legal business.

He claims to be carrying a firearm, per his denied request for a top in Ravalli county, and has posted photos of himself wearing a bullet proof vest, insinuating that he intends to be involved in a shootout with me or police.

He has been found at my home on three separate occasions where he took photos of my home, my vehicle, my mailbox, and my road sign. He then posted these photos on his many accounts to taunt and intimidate my wife and me to make us fear for our safety in our own home. (Pictures attached)

Mr. Windsor has for the last six months emailed hundreds of my coworkers hundreds of times each making false claims that I was going to kill him, that I was stalking him, that I have tried to kill him, and that I was the antagonist against him. These emails were sent to all staff and faculty at the University, many students, the board of regents, law enforcement in other counties, casual friends, and elected officials, ect. (Copies of emails attached.)

In summary, I would ask that the court award me this temporary order of protection based on the following.

45-5-220. Stalking -- exemption -- penalty. (1) A person commits the offense of stalking if the person purposely or knowingly causes another person substantial emotional distress or reasonable apprehension of bodily injury or death by repeatedly:

Mr. Windsor for the last six months has repeatedly caused my wife and me substantial emotional distress with his repeated emails and threats to have me confined and arrested.

His repeated occurrences at my home and posting of the photos of my home have caused me fear of bodily injury.


I have missed many days of work in the last two weeks in order to avoid Mr. Windsor.

I have lost many hours of sleep remaining awake to guard my home at night.

Mr. Windsor has repeatedly followed and intimidated me, by driving by my home, and coming to my workplace.

I would plead with the court for relief.





I returned to the office just after 3:00. At approximately 3:10 he entered the office and requested to speak with Charlie Janson. He was in the office about 10-15 minutes.

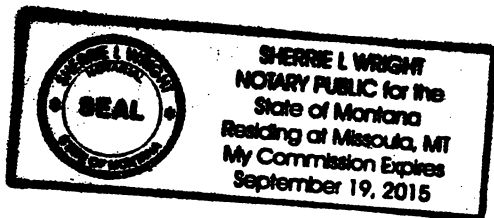

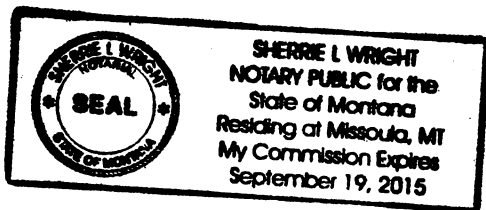

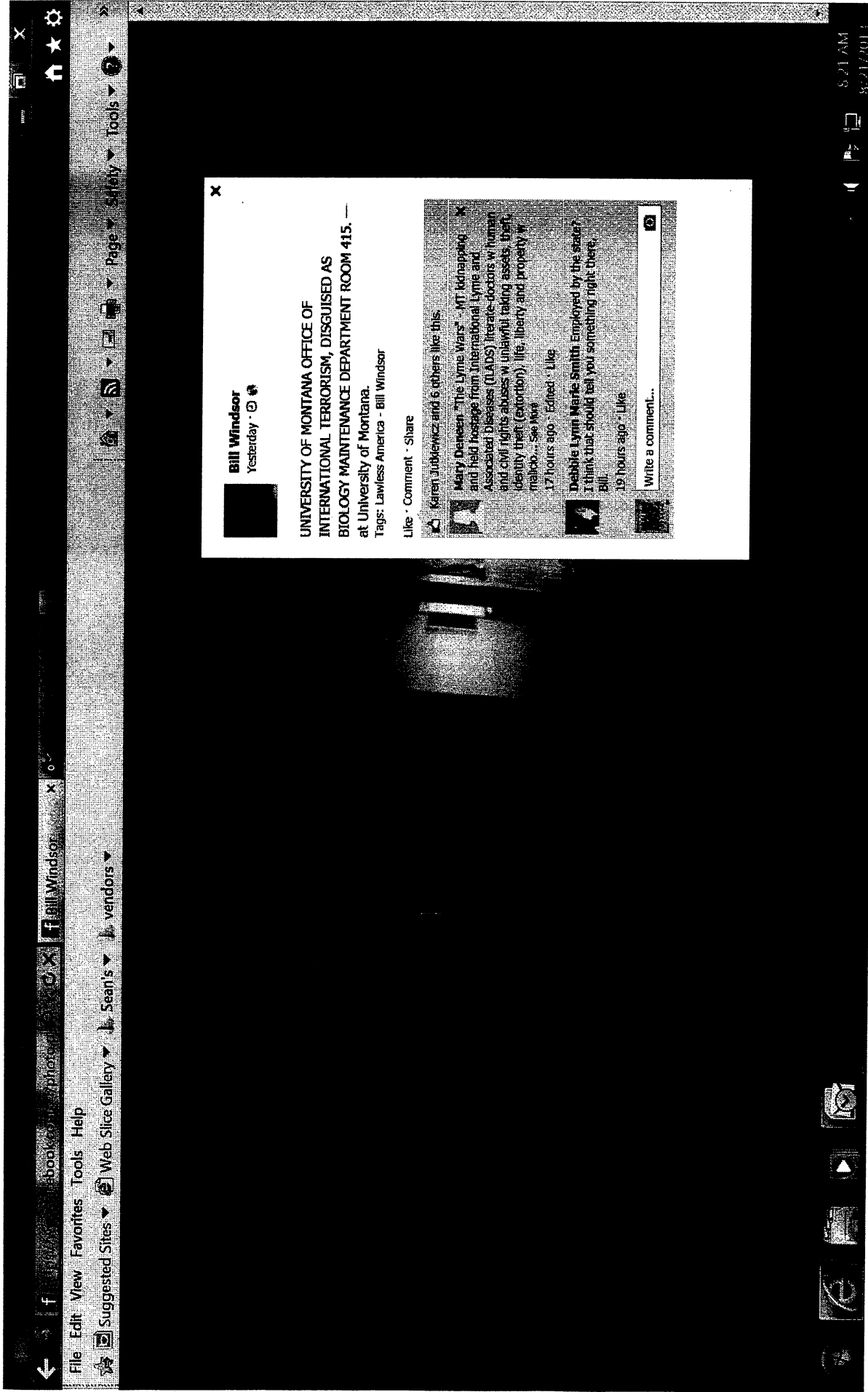
This afternoon, at about 3pm, Mr. Windsor asked to speak with me. I invited him into my office and he started by asking if I knew why he was wearing a bullet-proof vest. I told him I had no idea. He then stated that one of my employees, Sean Boushie, had a long history of threatening Mr. Windsor and in particular of cyber-stalking him using UM facilities during working hours. I responded that I had no knowledge of any such actions during his work hours and that Mr. Boushie was very busy during the workday, between his own support responsibilities for undergraduate lab courses and his supervision of two other full-time employees assisting in this task. Mr. Windsor then listed a long series of failures in convincing other jurisdictions to place a restraining order on Mr. Boushie and expressed his hope that he would succeed here in Missoula. I repeated that what he described as Mr. Boushie's behavior did not coincide with any reports from UM, either from faculty, staff, or students and that I had nothing to suggest that Mr. Boushie was engaging in any threatening activities while on UM property or elsewhere. Mr. Windsor asked if Mr. Boushie was in his office in the building, because he recognized Mr. Boushie's truck in the parking lot. I said I did not know Mr. Boushie's current location. Mr. Windsor left my office stating that he was going to go to Mr. Boushie's office to take pictures of it. After he left the main office of the Division of Biological Sciences, office staff alerted campus security of Mr. Windsor's presence in our building.

WARNINGS: This Order shall be enforced, even without registration, by the courts of any state, the District of Columbia, and U.S. Territory, and may be enforced on Tribal Lands (18 U.S.C. Section 2265). Crossing state, territorial, and tribal boundaries to violate this Order may result in federal imprisonment (18 U.S.C. Section 2262). Federal law provides penalties for possessing, transporting, shipping, or receiving any firearm or ammunition (18 U.S.C. Section 922(g)(8)(9)). Violation of this Order may be a criminal offense under applicable Federal or Tribal law and is a criminal offense under Mont. Code Ann. § 45-5-220 or § 45-5-626 and may carry penalties of up to \$10,000 in fines and up to a 5 year jail sentence. It is a misdemeanor under Montana Code Annotated 45-5-220 and/or 45-5-626 for the Respondent, even if invited and after notice of this Order, to violate the provisions of this Order. TEMPORARY ORDER OF PROTECTION AND ORDER SETTING HEARING

On 08/21, 20113, the Court considered the Petitioner's request for a Temporary Order of Protection.

THE COURT FINDS from the petition that the Petitioner is in danger of harm. **The court issues the following order immediately, under Mont. Code Ann. § 40-15-201 (2009), and without notice to the Respondent:**

6. Respondent must stay 1500 feet or other suitable distance _____ feet away from Petitioner's place of employment at: University of Montana

5 enforcement agencies: MISSOULA COUNTY SHERIFF'S OFFICE (Warrants).
