Narrative SEAN BOUSHIE reported he's the victim of stalking by WILLIAM "BILL" WINDSOR, who has driven across the country to harass Boushie while he's employed at the U of M by sending hundreds of emails to Boushie's coworkers claiming he's actually the victim of Boushie's actions, and photographing Boushie while he's in public. WINDSOR drives a white Jeep with "Lawless America" on it, and runs a website by the same name where he attempts to harass victims around the country through real and frivolous legal actions in return for legal settlements. WINDSOR wears a protective vest and is currently staying at the Marriott hotel, room 402.

Narrative On Aug. 23, 2013 I met with Sean Boushie at the police department after her came there to report harassment and stalking by another male. Mr. Boushie lives in Stevensville but works at the University of MT, in the biology department. He said for the past 18 months he's been the subject of online harassment from a male named William "Bill" Windsor. Mr. Windsor operates a website called LawlessAmerica.com and .org, and has also purchased the domain name seanboushie.com

Mr. Boushie told me that Mr. Windsor will send an email to unsuspecting people accusing them of some type of harassment or crime, and when they respond, he initiates an ongoing harassment campaign. He apparently also files frivolous legal actions against these people in hopes of getting them to reach legal settlements with him just to make him go away.

Earlier this month I was dispatched to a phone call request from a woman calling from Missouri, as I recall. She told me that a man named Bill Windsor was en route to Missoula, and that he actively engages in harassing people, and that he drives a white Jeep with "Lawless America" across the entire Jeep. At the time I took the CFS, we had no victim (yet) in Missoula, so I just notified the caller that we would have to wait and see what transpired, and concluded the call. She essentially was a victim of his campaign in her town, and wanted to give us a "head's up" that he was headed here.

Mr. Boushie told me the same thing, that Mr. Windsor drives a white Jeep with Lawless America written all over it, and that Mr. Windsor had no shown up at Mr. Boushie's place of work, and will photograph and record video of Mr. Boushie's vehicle when he's not around. Mr. Windsor has also made contact with dozens of Mr. Boushie's coworkers via email, claiming that Mr. Boushie is in fact stalking him, and routinely posts "updates" of Mr. Boushie's alleged activities on this lawlessamerica.com website.

Mr. Boushie had hundreds of printouts from the website showing web pages that contained what appeared to be absurd allegations that Mr. Boushie was harassing Mr. Windsor (I term them absurd because it does appear Mr. Windsor travelled all the way across country to intentionally engage in this behavior towards Mr. Boushie.)

Mr. Boushie also had dozens of email printouts his coworkers had received from Mr. Windsor alleging this harassment. When he reported this to the University of MT office of public safety, they told him there's no much they can do about it. Likewise, he's reported this to the Stevensville police department, but because almost all of the harassment has taken place on the U of M campus, they too told him there's not much they can do about it, according to him.

Mr. Boushie has an expandable file folder that is about four inches thick documenting this online harassment. He's had to disconnect his home phone (land line) due to the calls Mr. Windsor has made, and now only has a cell phone. Due

to call volume yesterday, I did not have a chance to review the websites he provided me.

Mr. Boushie told me Mr. Windsor is staying at the Courtyard by Marriott hotel on N. Reserve, in room 402.

Mr. Boushie said that his father was one of the Freeman who were arrested in Eureka many years ago, and his father hired a woman named Cathie Cox to harass Mr. Boushie following his arrest. Ms. Cox engaged in similar harassing behavior with phone calls and frivolous legal filings against Mr. Boushie. When she passed away, he believes that Mr. Windsor took over her list of victims, or people she was hired to harass. He only found out that she was hired to do this when they reviewed his father's bank statements, in which numerous monthly payments were made to Ms. Cox from his father's account. He told me that Ms. Cox's method was to file frivolous legal claims against people - as the Freeman were known to do - and force people to essentially provide a financial settlement with her to basically make her go away. According to Mr. Boushie, she was said to have amassed an estate estimated at \$6 million dollars from this action.

According to Mr. Boushie, Mr. Windsor has been ruled to be a "vexatious litigator" by numerous courts around the country due to his legal filings, in which the courts have specifically prohibited him from filing anymore legal documents without the permission or oversight of a licensed attorney.

He provided me with a cell phone number for Mr. Windsor of (770) 578-1094 which he said is on Mr. Windsor's websites. He also told me Mr. Windsor's Jeep has a Georgia license plate that starts with the letters BME, but unknown what the rest of it is.

Numerous comments posted on Mr. Windsor's websites, which were on the printouts Mr. Boushie showed me, indicate that there are other victims around the country who he's harassing. I provided Mr. Boushie with this report number and told him we'd start an investigation. Mr. Boushie told me he's been dealing with Mr. Windsor from across country, but now he's very concerned because Mr. Windsor is now in Missoula specifically to harass him and that he's "escalating" his behavior.

He told me Mr. Windsor actually tracked down Mr. Boushie's boss, and was taken into the University biology department and actually shown Mr. Boushie's office. He then showed me web page printouts from Mr. Windsor's website in which Mr. Windsor brags about the visit.

I then went to the Courtyard by Marriott and N. Reserve and observed a white Jeep with LawlessAmerica.com written all over it in professional signage.

I spoke to the general manager, Cathleen Small, about the situation and she recognized Mr. Windsor from other employees' concerns they'd shared with her. She told me he arrived in town almost three weeks ago, and immediately asked that his name not be given out to anyone who calls and inquires. He insisted that he be registered under a corporate name of Lawless America. Ms. Small said they get those requests occasionally from victims of domestic violence, etc, and were able to accommodate Mr. Windsor's request, but still needed a photo ID and credit card, which he provided to them. They don't keep that ID information on file, but just verify it.

The vehicle registration shows that the Jeep (license plate BME-8435) is registered to Mr. Windsor's wife, or a female with the same last name, out of Georgia.

The staff at the Marriott told me Mr. Windsor was happy to receive multiple boxes shipped to him several days after his arrival, and at one point he had mentioned to them "my bullet-proof vest arrived." He is now only seen by staff wearing that

vest, and does not leave his room without it. The rest of the boxes contained numerous pieces of computer equipment, they told me.

Mr. Windsor has reservations through Sunday, at which point the staff plan to tell him they are booked up due to prior reservations, based largely on their concerns about him. They said he behaves in an odd manner, and possibly has mental health issues.

At this time I did not attempt to make contact with Mr. Windsor.

I have also reviewed the TOP that was recently granted by city court to Mr. Boushie against Mr. Windsor, and the evidence outlined in that TOP, which paints an alarming picture of the level of harassment that Mr. Windsor has orchestrated against Mr. Boushie. That TOP has not been served as of Aug. 24th.

Additionally, in speaking about this matter to my supervisor, Cpl. Kelly advised me Mr. Windsor came in to file a police report earlier this month claiming he's actually the victim of cyber stalking by Mr. Boushie. That report, in which Officer Serba documents some apparent mental health problems in Mr. Windsor, is linked to this report.

I recommend that this report be assigned to a detective because there are several issues here, including stalking, privacy in communication and criminal defamation of character that need to be followed up on. Mr. Windsor's actions have seriously impacted Mr. Boushie's daily life, such that he's now carrying a sidearm in open carry (which he can't do on campus), and creating an emotional toll on him. I feel that this situation is probably outside the scope of what a CFS officer can handle due to daily call volume.

Narrative On the 4th of September, 2013, I spoke with Sean Boushie about this case involving Bill Windsor at the Missoula Police Department. Sean and I went over all that has happened in the past and discussed the serving of the restraining order on Windsor. Boushie and I spoke about where this all started with his father in-law and how his wife's father didn't want them to marry. Since Boushie's father in-law had been related to the "Freemen" of Northwest Montana, he was determined to break Boushie and the daughter up. Boushie stated his father in-law then began having him followed. Boushie stated this is where it all stemmed from and it was many years ago. After discussing more about his past and current situation, Boushie and I came to the agreement that since there were many First Amendment issues relating to the website Windsor created and that all the emails from Windsor being sent to the university were being diverted from Boushie's account, there aren't any laws being broken here. We spoke about the possibility of the violation of MCA Privacy in Communication, but didn't think this would work as well. After speaking to Boushie I spoke with Judge Karen Townsend about the up and coming TOP hearing and warned her about Windsor's bizarre actions. I also spoke with Missoula County Attorney Jason Marks about this case and he confirmed the absence of a MCA violation. At this point, the TOP has been put in place and Windsor has returned home. I would like to note that I have placed a thumb drive into evidence for information relating to all the legal action Boushie has endured regarding

On the 3rd of November, 2014, per the request of Missoula County Attorney Jennifer Clark, I video recorded the website William Windsor created with the name of Sean Boushie in the website name. This video file was presented to Clark's clerical worker on the same date.

Supplemental Report by Chris Shermer

On the 4th of September, 2013, Sean Boushie and I met at the Missoula Police Department. Boushie reported that at the hands of William Windsor he had been the victim of a substantial online harassment campaign.

Since then, members of the Missoula County Attorney's Office, the University of Montana (Boushie's place of employment) and I, have met regarding what course of action to take regarding Windsor's continuous harassment of Boushie.

It was documented that on August 21, 2013, Municipal Court Judge Warren granted Boushie a Temporary Order of Protection. The order was to remain in effect until September 16, 2013, unless continued at hearing. Windsor appealed to both District Court and subsequently the Montana Supreme Court. Judge Larson and the Montana Supreme Court both upheld the protective order. To date an initial hearing has yet to be held. However, per Judge Larson's November 14, 2013, to the original Order of Protection remains in effect until modified by the Municipal Court.

The order protects Sean M. Boushie, Wynette L. Boushie, and the University of Montana and its staff. Windsor was barred from harassing, annoying, disturbing the peace of, calling, emailing, contacting, or otherwise communicating directly or indirectly, with Sean M. Boushie, Wynette L. Boushie, and the University of Montana Staff. Further, Respondent was ordered to release www.seanboushie.com to Sean M. Boushie. Windsor was barred from posting petitioners name online.

On May 4, 2014, Windsor posted on his website, www.lawlessamerica.com, an article, authored by himself, which lists Sean Boushie's name three times.

On July 4, 2014, Windsor posted on his website, www.lawlessamerica.com, an article, authored by himself, which lists Sean Boushie's name once.

To date, control of the website www.seanboushie.com has not been released to Sean Boushie.

On December 30, 2013, Winsor posted a video on his Twitter account. The title reads "Bill Windsor is banned from the University of Montana and Sean Boushie. Corruption at its finest."

On February 6, 2014, Claudia Denker-Eccles, Associate Counsel for the University of Montana, received an email from Bill Windsor [Nobodies@att.net].

All five instances constitute individual violations of the Order of Protection.

The Missoula County Attorney's Office has this case and has charged Windsor for the five violations of the protective order, three of which are felonies based on the amount of violations. A warrant has been issued for Windsor's arrest.

On the 28th of September, 2014, I was notified Windsor was in a trial regarding other types of harassment by other individuals like Boushie. Since the warrant was still active, I made contact with the Ellis County Sheriff's Office and spoke with Chief Deputy Dennis Brearley regarding the warrant for Windsor's warrant. Deputy Brearley later informed me that Windsor was arrested for the warrant and still remains in jail.

This case is closed due to arrest and prosecution. The felony citation number is 081F10061.

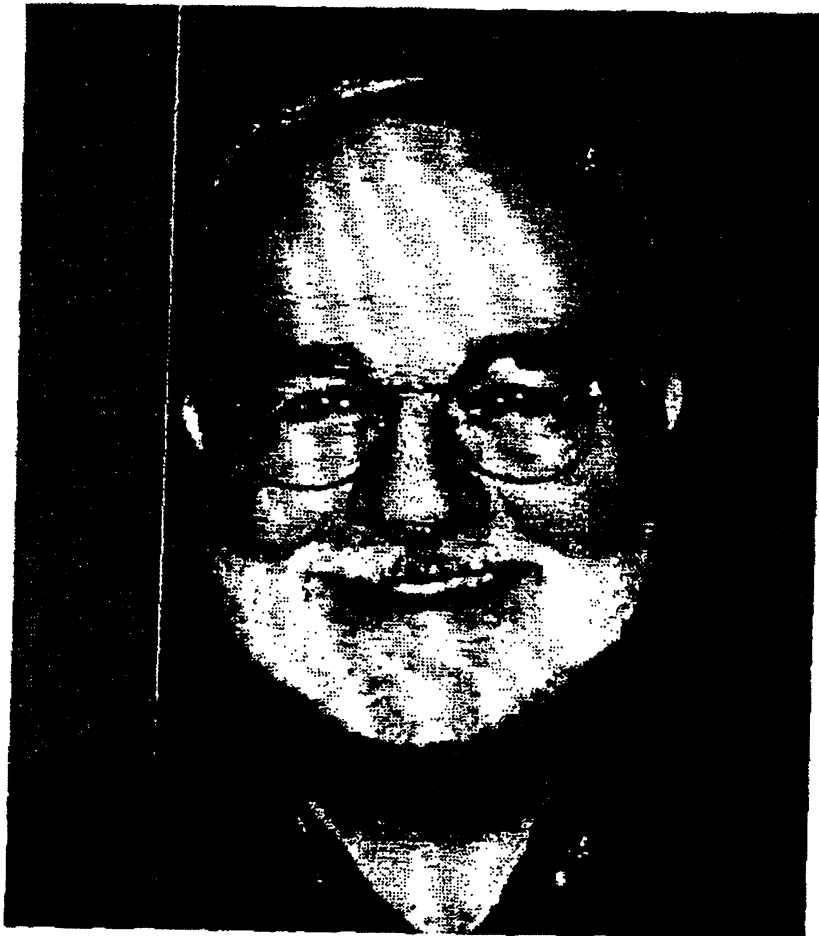

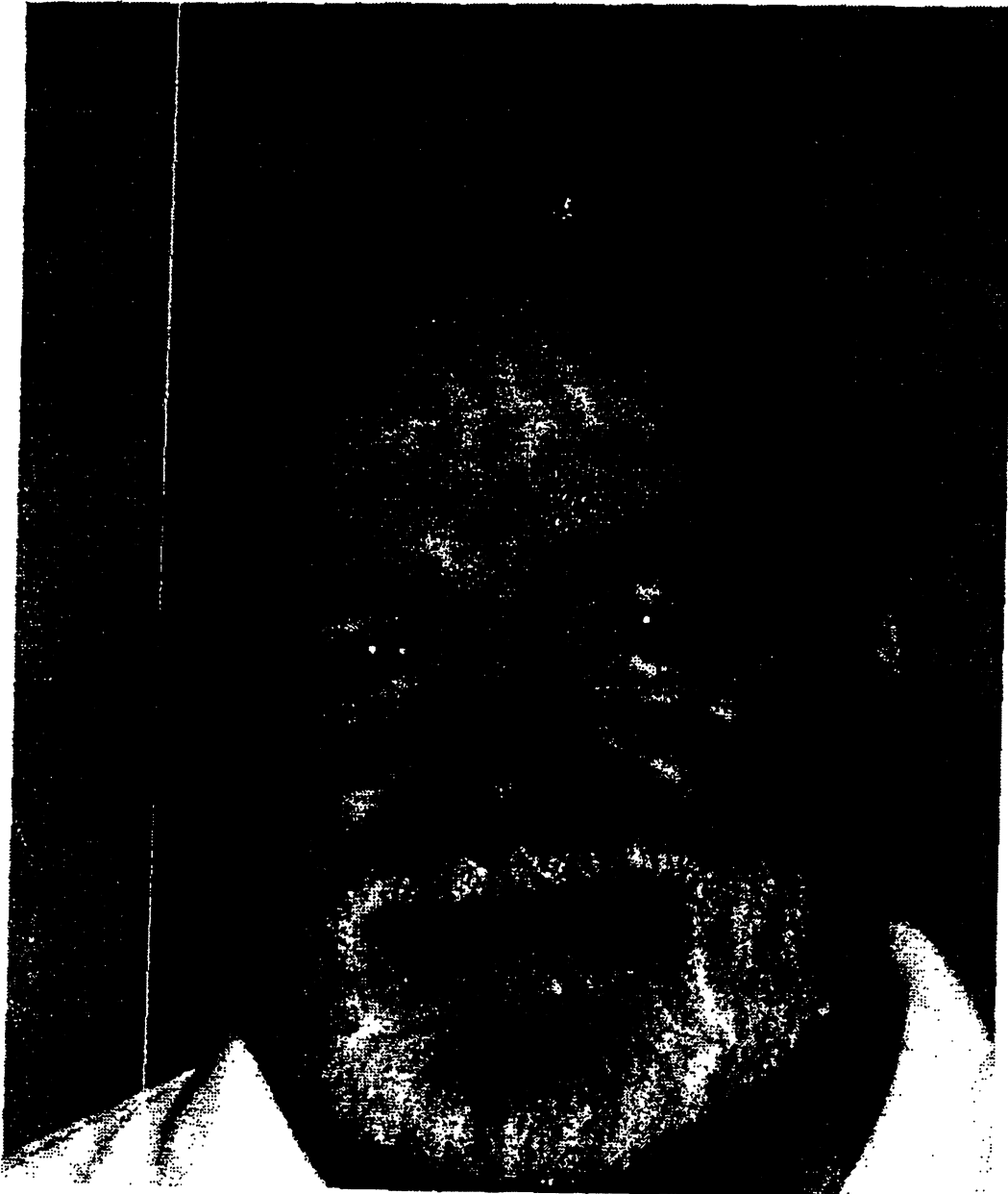
