William M. Windsor has filed a request to disqualify Judge James A. Haynes for cause from the above-entitled Missoula County Cause No. DC-14-509, pursuant to § 3-1-805, MCA.

Section 3-1-805, MCA, provides that an affidavit for disqualification will be set aside as void if it does not allege facts showing personal bias or prejudice. To the extent that Windsor makes specific allegations in his affidavit, those allegations may establish that Judge Haynes has ruled against Windsor and his apparent supporter in the past, but he does not allege facts showing personal bias or prejudice. As a result, it is unnecessary to appoint a district judge to hear this matter.

IT IS THEREFORE ORDERED that the request to disqualify District Judge James A. Haynes from Missoula County Cause No. DC-14-509 is DENIED.

The Clerk is directed to provide copies of this Order to the Clerk of the District Court of Missoula County for notification to all counsel of record in Cause No. DC-14-509, and to the Honorable James A. Haynes, presiding Judge.

William Michael Windsor filed a request to disqualify for cause the Honorable James A. Haynes from presiding in the above-entitled Missoula County Cause No. DC-14-509. On May 26, 2015, Chief Justice McGrath denied that request.

Windsor has now filed a "motion for reconsideration." Because there is no provision allowing reconsideration of a denial of a request for disqualification for cause under § 3-1-805, MCA, we have considered Windsor's motion as a petition for rehearing pursuant to M. R. App. P. 20.


A petition for rehearing will be considered only on grounds that the Court overlooked some fact material to the decision or some question presented that would have proven decisive to the case, or that the Court's decision conflicts with a statute or controlling decision that was not addressed. M. R. App. P. 20(1)(a). None of those circumstances are presented here.

Therefore,

IT IS ORDERED that the petition for rehearing is DENIED.
