Tyler Dugger, Intern – County Attorney, and Jennifer Clark, Chief Deputy County Attorney, deposes and says that on or about the 30th day of December, 2013, in Missoula County, the Defendant committed the offenses of COUNT I: VIOLATION OF ORDER OF PROTECTION - 1ST OFFENSE, a Misdemeanor, in violation of Montana law, namely: Mont. Code Ann. 45-5-626(3)[1st], punishable by 6 months MCDF and/or \$500 fine; COUNT II: VIOLATION OF ORDER OF PROTECTION - 2ND OFFENSE, a Misdemeanor, in violation of Montana law, namely: Mont. Code Ann. 45-5-626(3)[2nd], punishable by not less than 24 hours or more than 6 months MCDF and a \$200-\$500 fine; COUNT III: VIOLATION OF ORDER OF PROTECTION - 3RD OR SUBSEQUENT OFFENSE, a Felony, in violation of Montana law, namely: Mont. Code Ann. 45-5-626(3)[3rd], punishable by not less than 10 days or more than 2 years MCDF or MSP and

1 a \$500-\$2,000 fine; COUNT IV: VIOLATION OF ORDER OF PROTECTION - 3RD OR
2 SUBSEQUENT OFFENSE, a Felony, in violation of Montana law, namely: Mont. Code
3 Ann. 45-5-626(3)[3rd], punishable by not less than 10 days or more than 2 years MCDF or
4 MSP and a \$500-\$2,000 fine; COUNT V: VIOLATION OF ORDER OF PROTECTION -
5 3RD OR SUBSEQUENT OFFENSE, a Felony, in violation of Montana law, namely: Mont.
6 Code Ann. 45-5-626(3)[3rd], punishable by not less than 10 days or more than 2 years

9 COUNT I: On or about the 4th day of May, 2014, the above-named Defendant
10 committed the offense of violation of an order of protection when, with knowledge of the
11 order, purposely or knowingly violated a provision of an order provided for in 40-4-121 or
12 an order of protection under Title 40, chapter 15, to wit: Defendant posted an article on
13 his website, www.lawlessamerica.com, authored by himself, which mentioned Sean
14 Boushie three times.

15 COUNT II: On or about the 4th day of July, 2014, the above-named Defendant
16 committed the offense of violation of an order of protection when, with knowledge of the
17 order, purposely or knowingly violated a provision of an order provided for in 40-4-121 or
18 an order of protection under Title 40, chapter 15, to wit: Defendant posted an article on
19 his website, www.lawlessamerica.com, authored by himself, which mentioned Sean
20 Boushie once.

1 COUNT III: On or about the 2nd day of October, 2014, the above-named
2 Defendant committed the offense of violation of an order of protection when, with
3 knowledge of the order, purposely or knowingly violated a provision of an order provided
4 for in 40-4-121 or an order of protection under Title 40, chapter 15, to wit: Defendant has
5 not released control of the website www.seanboushie.com to Sean Boushie, a third or
6 subsequent offense.

7 COUNT IV: On or about the 30th day of December, 2013, the above-named
8 Defendant committed the offense of violation of an order of protection when, with
9 knowledge of the order, purposely or knowingly violated a provision of an order provided
10 for in 40-4-121 or an order of protection under Title 40, chapter 15, to wit: Defendant
11 posted Sean Boushie's name on Twitter, a third or subsequent offense.

12 COUNT V: On or about the 6th day of February, 2014, the above-named
13 Defendant committed the offense of violation of an order of protection when, with
14 knowledge of the order, purposely or knowingly violated a provision of an order provided
15 for in 40-4-121 or an order of protection under Title 40, chapter 15, to wit: Defendant
16 emailed Claudia Denker-Eccles, Associate Counsel for the University of Montana, a third
17 or subsequent offense.


