15 says that on or about and between August 24, 2013, through October 2, 2014, in Missoula
16 County, the Defendant committed the offenses of COUNT I: VIOLATION OF ORDER OF
17 PROTECTION - 1ST OFFENSE, a Misdemeanor, in violation of Montana law, namely:
18 Mont. Code Ann. 45-5-626(3)[1st], punishable by 6 months MCDF and/or \$500 fine;
19 COUNT II: VIOLATION OF ORDER OF PROTECTION - 2ND OFFENSE, a
20 Misdemeanor, in violation of Montana law, namely: Mont. Code Ann. 45-5-626(3)[2nd],
21 punishable by not less than 24 hours or more than 6 months MCDF and a \$200-\$500 fine.

1 The facts constituting the offense are:

2 COUNT I: On or about and between August 24, 2013 through October 2, 2014,
3 the above-named Defendant committed the offense of violation of an order of protection
4 when, with knowledge of the order, purposely or knowingly violated a provision of an
5 order provided for in 40-4-121 or an order of protection under Title 40, chapter 15, to
6 wit: Defendant has not released control of the website www.seanboushie.com to Sean
7 Boushie.

8 COUNT II: On or about the 6th day of February, 2014, the above-named
9 Defendant committed the offense of violation of an order of protection when, with
10 knowledge of the order, purposely or knowingly violated a provision of an order provided
11 for in 40-4-121 or an order of protection under Title 40, chapter 15, to wit: Defendant
12 emailed Claudia Denker-Eccles, Associate Counsel for the University of Montana.
