NOTICE OF APPEAL

WILLIAM M. WRAYSON ("RELATOR") HEREBY FILES THIS "APPEAL," AND SHOWS THE COURT AS FOLLOWS:

1. THE RELATOR APPEALS THE DENIAL OF BAIL ORDERED BY JUDGE CINDY ERMAINGER AT A HEARING ON NOVEMBER 2, 2014.
2. THE RELATOR APPEALS THE FAILURE OF JUDGE CINDY ERMAINGER TO RELEASE THE RELATOR AT HEARINGS ON NOVEMBER 21, 2014, NOVEMBER 25, 2014, AND DECEMBER 2, 2014.
3. THE RELATOR APPEALS THE DENIAL OF A HEARING BEFORE JUDGE CINDY ERMAINGER, JUDGE BOB CARROLL, THE MAGISTRATE WHO "ARRESTED" THE RELATOR, OR ANY OTHER JUDGE OR MAGISTRATE SINCE DECEMBER 2, 2014.

4. THE RELATOR HAS BEEN ILLEGALLY DETAINED, ILLEGALLY INCARCERATED, ILLEGALLY DENIED BOND, AND ILLEGALLY DENIED RELEASE AFTER 30 DAYS IN VIOLATION OF THE TEXAS CODE OF CRIMINAL PROCEDURE ARTICLE 51, SECTION 15.

5. THE FACTS AND THE LAW ARE DETAILED IN THE "FIRST AMENDED PETITION FOR WRIT OF HABEAS CORPUS" ATTACHED HERETO AS EXHIBIT A-1.

6. THE RELATOR HAS BEEN DENIED ANY ACCESS WHATSOEVER TO A LAW LIBRARIAN, SCRIBER, OR CASE LAW. IF THIS APPEAL WOULD BE BETTER CONSIDERED AS AN ORIGINAL PROCEEDING IN THIS COURT AS A PETITION FOR WRIT OF HABEAS CORPUS, THE RELATOR ASKS THE TEXAS COURT OF APPEALS TO SO CONSIDER IT.
