COURT AS FOLLOWS:

1. THE RELATOR APPEALS THE DENIAL  
OF BAIL ORDERED BY JUDGE CINDY  
EMMINGER AT A HEARING ON NOV  
DECEMBER 2, 2014.
2. THE RELATOR APPEALS THE FAILURE  
OF JUDGE CINDY EMMINGER TO
